

## **TRUVVI GRAND PRIZE KYNECT GETAWAY SWEEPSTAKES**

### **Official Rules**

**YOU MUST BE PRESENT TO WIN. NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

The TruKynection Sweepstakes ("Sweepstakes") is sponsored by Kynect Nationwide, LLC. ("Kynect"), 14675 Dallas Parkway, Suite 150, Dallas, Texas, 75254.

1. **Sweepstakes Period:** The Sweepstakes starts on September 12, 2020 at 9:00AM Central Standard Time ("CST") and ends on September 19, 2020 at 11:59PM CST ("Sweepstakes Period"). Kynect's computer is the Sweepstakes' official clock.
2. **Eligibility:** This Sweepstakes is only open to Kynect Independent Associates who fulfill all of the following eligibility requirements: (i) registered for the online TruKynection September 12, 2020 event, (ii) purchase a monthly or yearly subscription to Truvvi, (iii) in good standing (i.e., are not suspended, terminated, or under investigation by Kynect's Business Integrity Group).  
Kynect's employees/officers/directors/ agents, their direct family members, and/or individuals living in their households (regardless of relationship) are not eligible. All applicable federal, state, and local laws and regulations apply. This Sweepstakes is void where prohibited by law.
3. **How to register and enter the Sweepstakes:** During the Sweepstakes Period, there are three (3) ways to enter the Sweepstakes:
  - a. Each eligible Entrant will receive one entry by purchasing a monthly subscription to Truvvi and/or selling a monthly subscription to Truvvi, or
  - b. Each eligible Entrant will receive five entries by purchasing a yearly subscription to Truvvi and/or selling a yearly subscription to Truvvi, or

**LIMITS: One (1) entry for your own monthly Truvvi Subscription; one (1) entry for a new member's monthly subscription; five (5) entries per Yearly Truvvi Subscription; ten (10) entries per mail-in entry for the entire Sweepstakes Period.** Maximum of 10 total entries per person.

4. **Random Drawings.** On September 20, 2020, following the TruKynection event, Kynect will randomly select one (1) potential "Prize" (defined in Rule #5) Winner from among all eligible Entries received during the Sweepstakes Period. Each Prize Winner is considered a potential Winner pending verification of eligibility and compliance with these Official Rules. All Prize winners may be referred to collectively as "Winner(s)".
5. **Prize, Odds of Winning, and Approximate Retail Value ("ARV"):**
  - a. **Prize:** Winner will receive a trip for two (2) on the upcoming Kynect Getaway, scheduled for October 22 – 26, 2020 . One (1) Prize will be awarded in the Sweepstakes. The ARV of the Prize is \$2,400, including a \$400 airfare credit. If Kynect cancels the trip due to any COVID-19 related reason, the winner will receive the prize's ARV. Winner must sign release and waiver form, as provided by Kynect, prior to redeeming prize. - b. **Odds of Winning:** The odds of winning the Prize depend upon the number of eligible entries received during the Sweepstakes Period.
  - c. **Total ARV:** The total ARV of the Prize is \$2,400.
  - d. **General:** No more than one (1) Prize will be awarded in the Sweepstakes. If the Prize is unclaimed, unredeemed, or returned as undeliverable it may not be awarded. If, after a good-faith attempt, Sponsor is unable to award or deliver the Prize, the Prize may not be re-awarded.

The AAA Rules for selection of an arbitrator shall be followed, except that the arbitrator shall be experienced and licensed to practice law in the State of Texas. The remedy for any claim shall be limited to actual damages, and in no event shall an Entrant or any other party be entitled to recover punitive, exemplary, special, incidental, indirect and consequential damages or any other damages (whether due to negligence or otherwise), other than for actual out-of-pocket costs described in this Rule #8, nor will an Entrant or any party be entitled to have damages multiplied or otherwise increased or to rescind this agreement or seek injunctive or any other equitable relief. Entrants agree that the statute of limitations for asserting any claims shall be a period of one (1) year from the end date of the Sweepstakes Period. Entrants agree that any and all disputes, claims, and causes of actions arising out of or connected with the Sweepstakes or any Prize awarded shall be resolved individually, without resort to any form of class action.

9. **PRIVACY / USE OF PERSONAL INFORMATION:** *Please note*, if eligible Entrant, is considered a minor in your jurisdiction of residence (generally, a minor is under eighteen (18) years of age), eligible Entrant must first get their parent/legal guardian's permission before participating in the Sweepstakes.
