MARKET SNAPSHOT: FIRST QUARTER 2023



OVERVIEW

- VOLUME SALES DOWN 44% FROM Q1-2022, WITH UNIT SALES DOWN 32%
- NEW LISTINGS UP 18% FROM Q1-2022, WITH EXPIRED LISTINGS UP 233%, SALES/LISTINGS RATIO OF 35% DOWN 27%
- AVERAGE SALE PRICE DOWN 17% FROM ONE YEAR AGO, WITH AVERAGE DAYS-ON-MARKET OF 56 UP 37 DAYS.
- BUYERS' MARKET: DEMAND FOR LISTINGS LESS THAN SUPPLY.
