TERMS AND CONDITIONS OF SALE

Nonprofit Commissions and Transaction Fees

Members who receive traffic from Nonprofit Members and pay a commission and transaction fee in exchange for a successful sale will hereby be known as Merchant Members.

Customers who have been referred to Merchant Member websites from Nonprofit Member affiliate links and who make a purchase will result in the Nonprofit Member being credited with a commission of between 5% and 10% of the sale.

Support4Good LLC will take a 5% transaction fee from Merchant Members on top of the 5%-10% commission on every purchase made by a referral customer for a total of 10-15% commission per successful purchase to be paid by the Merchant Member to Support4Good. Support4Good will pay Nonprofit Members the 5%-10% commission owed for purchases coming from successful referrals to Merchant Members.

Merchant Members will be charged for owed commissions on a monthly basis via Stripe. All credit card information is stored with Stripe, no credit card information is stored on Support4Good servers. It is simply passed on to Stripe. This is a security measure.

In the event that Merchant Member internal policies prevent putting a credit card on file, Support4Good will invoice the Merchant Membe Hi! How can we help you?

Nonprofit Members will be paid commissions 30 days after they have met their minimum threshold requirements or the nearest date the bank is open, in the even of a weekend or holiday when bank transfers cannot be completed. Nonprofit Members will only be paid when they have earned the minimum payout threshold (currently ¥10000). The minimum threshold for payout is subject to change.

Paid Products

Support4Good does not currently provide products for sale on this websites, but may decide at any time to do so. The following sections are set in place to provide for policies whenever products are available for purchase.

Indemnification
